


- Age guidelines
- Under 18 and need a guardian
- ID guidelines
 - All IDs must be original (not a photocopy or digital ID), valid (unexpired), and government issued.
 - IDs are valid (unexpired) if they do not contain an expiration date that has passed. If there is no expiration date on an ID, it is valid.
 - All IDs must include the candidate's name and recent, recognizable photo. A visible signature is not required.
 - All IDs must have a first and last name that matches the first and last name the candidate used to
 - register (the name in the ProctorServ system)
 - Restricted IDs
 - Geneva Convention ID card
 - Canadian health insurance card (issued by any province)
 - U.S. House of Representatives ID
 - U.S. military ID
 - U.S. Senate ID
- At home testing option
 - Not intended to replace a site

- Due to the widespread impact of the transfer/outages, GED will not be testing during this time


